## Virtual Special Meeting Public Notice

Governor Ron DeSantis signed Executive Order 20-69, which suspended all statutes that require a quorum to be present in person or require a local government body to meet at a specific public place, which was last extended pursuant to Executive Order 20-179. It also provides that local government bodies may utilize communications media technology, such as telephonic and video conferencing, as provided in section 120.54(5)(b)2, Florida Statutes.
