NEWS RELEASE - COVID-19 (Coronavirus) #20 **City of Lauderhill Encourages the Use of Face Coverings to Help Stop the Spread of COVID-19**

Lauderhill, FL – April 9, 2020 – 6:00 PM – The City of Lauderhill has issued [Emergency Order #20-08](#). This Emergency Order encourages all persons outside of their homes in the City of Lauderhill to wear masks. For the purposes of the Order, we encourage you to utilize cloth masks or any other cloth face coverings consistent with the [current Centers for Disease Control's guidelines](#) to ensure the supply of surgical masks are available for medical professionals and first responders. With that, [SOE #20-08](#) states all Personal Protective Equipment to include items like gloves and masks should be disposed of in trash containers and not the ground.

The Staff, Mayor, and City Commissioners still strongly encourage everyone in the City of Lauderhill to stay safe and stay home, as we continue to fight the spread of COVID-19 in our City.
